14.10 Break Out Sessions:

Group 1. Early Contractor Involvement (ECI) : Pros, Cons, When to Use & Good Practice for different types. (Jon Broome, Neil Earnshaw)

This interactive workshop will use participants' thoughts and experience to develop guidance on the pros and cons of at least 5 different types of Early Contractor Involvement and, from that, when is best to use each type. Further, participants will be encouraged to identify and come to a view on any amendments or additions needed to the standard NEC contract clauses and share any tips on best practice. The results will be promptly written up and shared amongst the community

Group 2. NEC5 – What would you want to see in future revisions of the contract? (Glenn Hide, Chris Woodbridge)

The presenters will share some ideas of development they want to see included in future versions of the contract for the group to consider, before drawing on the groups ideas/experience as to other changes that are still needed to further improve NEC contracts. We will then collate and publish a list of standard additional amendments recommended/endorsed by the group that Clients/Contractors can include in their future contracts before they are eventually may be included in NEC5 – and putting Z clauses to good use (for a change, some might say!)

Group 3. Alternative ways of structuring the Fee in an Option C or E contract to optimise delivery and also on considering Disallowed Costs – the good, the bad and the ugly. (Matthew Smith, Nicola Ellis, Seamus O'Doherty)

This workshop will consider strategies to optimise the fee structure to incentivise collaboration and delivery. We will also consider the approach to Disallowed Costs including how it should be applied correctly and experiences of how Disallowed Cost has been improperly amended or applied. The objective would be to prepare a good practice guide as to how they should be understood and managed for the benefit of all Parties.
